The academic staff who will apply for the first time should pre-register to the system via the "Register & apply" tab at

https://exchangeprogram.gop.edu.tr/Account/Login.aspx?pld=2035&ReturnUrl=%2F and then they must log in and complete their applications by Monday, 22 March 2021, 23:59.

Academic staff who previously benefited from the Erasmus program will be able to log into the system with their username and password as their TR identity number at https://exchangeprogram.gop.edu.tr/Account/Login.aspx?pld=2035&ReturnUrl=%2F.

The academic staff who apply are obliged to complete the exchange activity until 31.05.2022.

Evaluation;

Due to limited grants, priority will be given to the personnel who did not benefit from staff mobility before, to departments or units that were not involved in teaching mobility activities before, to applicants who have not been involved in teaching mobility activities before or who plan to carry out mobility activities with certain countries / higher education institutions / businesses.

The evaluation of the applications will be made according to the scoring system. In cases where the scores are equal, the candidate's foreign language knowledge scores (YDS, TOEFL, IELTS, etc.), the candidate's scientific publications and the number of citations and years of service are taken into account in the evaluation.

EVALUATION CRITERIA FOR ERASMUS STAFF EXCHANGE

Having not benefited from the Erasmus Program before	5 points
Having bilateral agreements before (if there is more than one agreement, the number of agreements x 5 points)	5 points
Being an Erasmus Unit / Department Coordinator	5 points
Not having benefited from Erasmus activity as the department / unit / department before	5 points

As a result of the evaluations, the academic staff announced in the main list are required to submit their acceptance letters to the Office within thirty days after the end of the announcement. At the end of the thirty-day period, the rights of the academic staff who cannot provide an acceptance letter are transferred to the lecturers who are on the reserve list.

All applications will be made to the Erasmus Coordinator. Among the candidates applying to our coordinatorship, principal and reserve lists will be created in line with the above criteria and will be announced on the website of the Erasmus Office. (erasmus.gop.edu.tr)

Some changes were made between 2007-2014 Lifelong Learning / Erasmus Program and Erasmus + program implemented between 2014-2021 in terms of grant usage. Accordingly, the daily grant amount, travel payments, the countries to be visited, the duration of the activity may differ from the previous period.

Related Changes:

- 1. The mobility period, which was at least 5 working days before, has changed to be at least 2 working days. Staff mobility period is minimum 2 days and maximum 2 months. However, our Unit has limited the period of grant payments within the scope of Erasmus staff mobility to a minimum of 2 working days and a maximum of 5 working days in order to ensure that more of our staff can benefit from the mobility with the current grant.
- 2. Conference attendance will not be granted within the scope of the Erasmus Program in the 2014-2021 period.
- 3. As known, travel distance in travel expenses will be calculated using the distance calculator provided by the European Commission. For example; An instructor who will go to Rzeszow to give lectures, after determining the distance between Tokat-Rzeszow in this link, should calculate the travel cost to be paid to him according to the distance range in the announcement text. - 4. In the previous period, only EU member countries could be visited, but with the new term, Macedonia, Liechtenstein, Iceland and Norway can also be visited within the scope of

education mobility, as well as 28 EU member countries.
